# HALCO's Ryan Peck Receives the Sidney B. Linden Award


**Ryan Peck**, HALCO's executive director and lawyer, received the **Sidney B. Linden Award** from Legal Aid Ontario on February 23, 2017.

# Campaign to Stop Unjust HIV-related Criminal Prosecutions in Ontario

People living with HIV continue to be charged with aggravated sexual assault – one of the most serious offences in Canada's Criminal Code, designed to respond to the most horrific of forced sex acts — which carries a maximum penalty of life imprisonment and designation as a sex offender. These prosecutions are happening even in circumstances where:

- (i) sexual behaviour is consensual;
- (ii) there is negligible to no risk of HIV transmission;
- (iii) there is no intention to transmit HIV; and
- (iv) transmission does not occur.

However, the problematic nature of the current use of the criminal law is finally being recognized by government. As we reported in our **Autumn/Winter 2016 newsletter**, on December 1, 2016, after many years of silence, the federal government is speaking up. In a World AIDS Day 2016 statement, federal Minister of Justice **Jody Wilson-Raybould** stated, "[T]he over-criminalization of HIV nondisclosure discourages many individuals from being tested and seeking treatment, and further stigmatizes those living with HIV or AIDS. Just as treatment has progressed, the criminal justice system must adapt to better reflect the current scientific evidence on the realities of this disease." Further, the Minister committed to working with provincial and territorial counterparts, medical professionals and affected communities to examine this issue.



To date, the federal government has consulted with the HIV community, including through a meeting with the Canadian Coalition to Reform HIV Criminalization (www.aidslaw.ca/site/canadian-coalition-to-reform-hiv-criminalization/?lang=en).

In addition, HALCO and the Canadian HIV/AIDS Legal Network provided the federal government with a brief "Exploring Avenues to Address Problematic Prosecutions Against People Living with HIV in Canada", which is available on our website: www.halco.org/2017/news/new-brief-exploring-avenues-to-address-problematic-prosecutions-against-people-living-with-hiv-in-canada.

In March 2017, a meeting took place between the federal government and provincial and territorial counterparts to discuss this issue.

At the same time, the **Ontario Working Group on Criminal Law and HIV Exposure (CLHE)** continues to advocate for change at the provincial level. Currently, CLHE is requesting that Ontario Attorney General **Yasir Naqvi**:

- 1. Impose an immediate moratorium on all HIV non-disclosure prosecutions, unless there is alleged intentional transmission of HIV, while law reform options are being explored and sound prosecutorial guidelines are being developed in conjunction with the community to limit the current misuse and overextension of the criminal law.
- 2. Publicly state that the Ontario Ministry of the Attorney General is committed to ending the overly broad application of the criminal law in cases of alleged HIV non-disclosure and to reviewing Ontario's approach to these prosecutions.
- 3. Engage in meaningful dialogue with CLHE as well as people living with HIV and scientific experts when developing prosecutorial guidelines and other responses to this issue.

# Mileage Rate Increase for Social Assistance Recipients (ODSP and OW)

The mileage rate for people in receipt of Ontario Disability Support Program (ODSP) or Ontario Works (OW) benefits has increased to:

- 40 cents per kilometre (previous rate was 18 cents)
- 41 cents per kilometre for the north and northeast regions of Ontario (was 18.5 cents)

The mileage rate increase for medical travel is retroactive to October 1, 2016. The Ontario government website indicates that ODSP and OW recipients who were eligible for and received mileage for medical travel since October 1, 2016 will receive retroactive payment for the increase.



The business expense deduction mileage rate increases started on January 9, 2017, and are for ODSP and OW recipients:

- who are self-employed and use their personal vehicle for travel that is necessary for their business, and
- where the purpose of travel is to generate income.

# **Employment Insurance (EI) Waiting Period Reduced to 1 Week**

The Canadian government announced in the 2016 budget that the waiting period for Employment Insurance (EI) benefits would be reduced from 2 weeks to 1 week. This change took effect on January 1, 2017, and applies to EI claims filed on or after January 1, 2017. The EI waiting period had been 2 years since 1971. ### **HIV and Private Insurance**

#### **Travel Medical Insurance**

In November 2015, the Ontario Human Rights Commission website reported about emergency travel medical insurance and HIV. Here is information from the ORHC website: www.ohrc.on.ca/en/news\_centre/insurer-removes-hivaids-exclusion-emergency-travel-medical-insurance-policy:

In May 2015, the Ontario Human Rights Commission (OHRC) learned that a Canadian insurance company (RSA Canada) would not issue an emergency travel medical insurance policy to anyone who had ever been diagnosed with HIV or AIDS and obtained a copy of the exclusionary policy.

The OHRC wrote to RSA Canada to express concern that the HIV/AIDS exclusion might contravene Ontario's Human Rights Code.

While exceptions in the Code allow insurers to make distinctions based on certain Code grounds (including disability), the distinctions must be reasonable and bona fide. The Supreme Court of Canada has established a test for determining whether a rule or restriction is bona fide.

In October 2015, RSA Canada advised the OHRC that it had removed the HIV/AIDS exclusion from the emergency travel medical insurance policy, and that individuals with HIV/AIDS will now be treated in the same way as people with other pre-existing medical conditions.

The OHRC recommends that all organizations identify and remove barriers to human rights. We encourage all insurers to review their policies for similar eligibility exclusions, and to ensure equitable coverage for persons living with HIV and other disabilities.

#### Life Insurance

As we reported in our **Spring 2016 newsletter**, life insurance is available in Canada to people living with HIV. In April 2016, Manulife announced that it would accept applications for individual life insurance policies for people living with HIV. In November 2016, Sun Life made a similar announcement.

HALCO views this as a significant step towards insurance companies basing their policies for people living with HIV on current medical and scientific evidence. While HALCO is encouraged to hear that Canadian insurers are offering life insurance to people living with HIV, we do not in any way endorse these companies or particular products.

# Fourth Increase to Legal Aid Ontario Financial Eligibility Guidelines

Legal Aid Ontario (LAO) imposes financial eligibility guidelines for most legal aid services, including for services provided by community legal clinics such as HALCO.

We welcome the fourth increase to Legal Aid Ontario financial eligibility guidelines, which began April 1, 2017. On November 1, 2014, the first increase since 1994 took effect, followed by increases on April 1, 2015, and April 1, 2016.

These increases to the guidelines expand access to justice in Ontario as more low income people in Ontario become eligible for LAO services.

# HALCO Is Developing a New Strategic Plan

In early 2017, HALCO began the process to develop a new Strategic Plan to guide our activities for the next three to five years.

We are collecting feedback from a wide range of people and groups as part of our planning process, with the key group being people living with HIV in Ontario.

Our Strategic Plan development activities include:

- meeting and consultations with our board of directors and staff.
- a survey for people living with HIV.
- focus groups with people living with HIV.
- surveys and focus groups with key stakeholders including staff from AIDS service organizations, health care providers, community legal clinics, other community agencies, and funders.

To assist us in this process, we engaged the services of the consulting firm of SN Management. We anticipate that our new Strategic Plan will be completed and launched by fall 2017.

# HIV Testing and Reporting in Ontario

The reporting regulation under the *Health Protection and Promotion Act* (HPPA) changed: the names and contact information of people who test positive for HIV at anonymous testing clinics may **not** have to be reported to Public Health in Ontario.

If you have your initial HIV test at an anonymous testing clinic you may be able to use your positive anonymous HIV test code to have anonymous HIV viral load testing. This may significantly reduce the likelihood of your name and HIV status being reported to Public Health authorities.

Anonymous HIV tests are free in Ontario, and you do not need an Ontario Health Insurance Plan (OHIP) card or number to get an anonymous HIV test.

## TRANSforming JUSTICE: Trans\* Legal Needs Assessment Ontario Project

HALCO is administering the TRANS*forming* JUSTICE: Trans\* Legal Needs Assessment Ontario project.

The data collection phase of the project has been completed and analysis of the data is taking place now. It is anticipated that findings and recommendations will be released over the coming months.

The project uses "trans" as an umbrella term to refer to people whose gender identity or expression is not reflected by the sex assigned to them at birth, including people who identify as two-spirit, non-binary, agender, gender queer, cross dresser, transgender, or transsexual, as well as those who identify as men or women with a history that involves a gender transition. While the project is focussed on the needs of the broader trans community, a specific component of the project is dedicated to trans people living with HIV.

Funded by Legal Aid Ontario (LAO) and the Ontario HIV Treatment Network, the project gathered data from members of trans communities as well as legal service providers.

Project partners include HALCO, Western University, the University of Toronto and Ryerson University. HALCO is the lead organization on the project and **N. Nicole Nussbaum** is the project lead.

Statement of Principles of the HIV & AIDS Legal Clinic Ontario Adopted January 30, 2006, by the Board of Directors

#### It is agreed that:

- 1. People living with HIV/AIDS are confronted with unique legal problems of enormous proportions and complexity;
- 2. Those best equipped to make choices regarding HIV/AIDS issues and problems are those individuals who are HIV positive themselves;
- 3. People living with HIV/AIDS must have control over their own lives;
- 4. The HIV/AIDS affected communities are very diverse and are confronted by overwhelming challenges derived from both their diversity and from their common experience as people living with HIV/AIDS;
- 5. It is necessary to create and foster a climate of understanding and mutual respect for the dignity and worth of people living with HIV/AIDS; and
- 6. The confidentiality, bodily security, autonomy and privacy of people living with HIV/AIDS must be respected, which include but are not limited to:
  - a) the right of individuals to exercise control over their own medical treatment;
  - b) the right of individuals to exercise control over decisions concerning their own socio-economic position;
  - the right of all persons living with HIV/AIDS to be fully informed of all processes and procedures in which their interests are in any way involved; and
  - d) the right of all persons living with HIV/AIDS to consent, or withhold their consent, in all matters affecting them.
